AUDIT SUMMARY

Results in brief

In most areas we audited, Port operations complied with applicable requirements and provided adequate safeguarding of public resources. The Port also complied with state laws and regulations and its own policies and procedures in the areas we examined.

However, we noted certain matters that we communicated to the Port management in a letter dated September 29, 2014 related to cash receipting and procurement of public works projects and emergency procedures. We appreciate the Port's commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of the Port of Edmonds from January 1, 2012 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the Port's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Cash-receipting
- Procurement
- Financial condition
- Disbursements

Our opinion on the Port's financial statements is provided in a separate report, which includes the Port's financial statements.

INFORMATION ABOUT THE PORT

The Port of Edmonds, located in Snohomish County, operates a marina for recreational boating on Puget Sound and rents its land and buildings to commercial users. The facility consists of the marina with approximately 660 slips, a dry stack storage facility with approximately 230 spaces, two public boat launches, a boatyard, a fuel dock, guest moorage, offices and parking facilities. In addition to the Port's marina operations, the Port owns and manages eight buildings and rents portions of those buildings to approximately 60 tenants. The Port also leases land to retail and office buildings, an athletic club, a hotel and a boat sales and service company.

The Port District serves over 18,000 citizens. An elected, five-member Board of Commissioners governs the Port. Board Members serve staggered, four-year terms. The Board appoints management to oversee the Port's daily operations as well as its approximately 30 employees. The Port is supported primarily through user fees. For 2012 and 2013, the Port operated on an annual budget of \$6,822,900 and \$6,829,300, respectively.
