MARINA TENANT NOTICES

Thank you for your continued tenancy in 2022. With the new year upon us, we have some reminders to share with you:

2022 Moorage & Dry Storage Rates

New rates went into effect January 1, 2022 and can be found on the Port's website: www.portofedmonds.org

Tenant Security Deposits

Deposits were adjusted to match new 2022 base rates. This adjustment appeared on your January statement as line item titled Deposit-Charge-SECURITY DEPOSIT.

Parking Permits

Permits are available for pick up at the Marina Operations service window. Tenants are allotted two parking permits per slip, and you can purchase a third for \$50.00 + tax. To receive your to passes, please remember that the Port must have the following documents on file:

- 1) Current insurance, including \$500,000 worth of coverage for both watercraft liability and pollution or fuel spill liability. If pollution or fuel spill liability is not explicitly outlined on your declarations page, you must provide supplemental proof of coverage.
- 2) Current WA State registration or Coast Guard Documentation
